### GENERAL PROVISIONS

<b>THE FOUR DIVISIONS</b>	The Northwest Saddlebred Open Futurity will be shown each year in four divisions.								
<b>WHAT FOALS ARE ELIGIBLE?</b>	All foals shown must be the produce of stallions and mare who have been nominated in the Northwest Saddlebred Open Futurity.								
<b>HOW TO NOMINATE THE SIRE</b>	<b>NOMINATION OF SIRE</b> To nominate a sire in the Futurity it is necessary: (1) That the stallion be registered in the American Saddlebred Registry Stud Book. (2) That a fee of \$50.00 be paid to the Futurity on or before June 15 th of the year in which the foal is nominated.								
<b>HOW TO NOMINATE THE DAM</b>	<b>NOMINATION OF DAM</b> To nominate a mare in the Futurity it is necessary: (1) That the mare be registered in the American Saddlebred Registry Stud Book. (2) That a fee of \$15.00 be paid to the Futurity on or before June 15th of the year in which the foal is to be eligible for the Weanling Division of the Futurity								
<b>HOW TO MAKE A WEANLING ELIGIBLE</b>	<b>THE WEANLING DIVISION</b> <b>All weanlings must be registered before they can be shown.</b> In order to make a foal eligible to show in the Weanling Division of the Futurity, the following conditions must be complied with: (1) <b>The sire and dam must be nominated in the Futurity the year in which the foal is born.</b> (2) The foal must be registered with the American Saddlebred Registry before it can be shown. To be eligible to show as a yearling and/or a two-year old, it must have been registered by December 31st of the year foaled. (3) \$25.00 must be paid to the Futurity on or before June 15th of the year the foal is born. <b>HOW SHOWN.</b> The entries in this division will be shown In Hand.								
<b>HOW TO KEEP THE YEARLING ELIGIBLE</b>	<b>THE YEARLING DIVISION</b> In order to make a colt, filly or gelding eligible to show in the Yearling Division of the Futurity, the following conditions must be complied with: (1) The colt, filly or gelding must have been entered in the Weanling Division of this Futurity and all conditions and requirements of that Division must have been fulfilled. (2) \$25.00 must be paid to the Futurity on or before June 15th of the year following the birth of the foal. <b>HOW SHOWN.</b> The entries in this division will be shown In Hand.								
<b>HOW TO KEEP THE TWO-YEAR-OLD ELIGIBLE</b>	<b>THE TWO-YEAR-OLD DIVISION</b> In order to make a colt, filly, or gelding eligible to show in the Two-Year-Old Division of the Futurity, the following conditions must be complied with: (1) The colt, filly or gelding must have been entered in the Weanling and Yearling Divisions of this Futurity and all conditions and requirements of those Divisions must have been fulfilled. (2) \$25.00 must be paid to the Futurity on or before June 15th of the year the entry becomes a two-year-old. <b>HOW SHOWN.</b> The entries in the division shall be shown as (1) Fine Harness, (2) In Hand, (3) Under Saddle Three Gaited with full mane and tail. Horses can be shown In Hand and in one performance class in this Division.								
<b>HOW TO KEEP THE THREE-YEAR-OLD ELIGIBLE</b>	<b>THE THREE-YEAR-OLD DIVISION</b> In order to make a colt, filly or gelding eligible to show in the Three-Year-Old Division of the Futurity the following conditions must be complied with: (1) The colt, filly or gelding must have been entered in the Weanling, Yearling and Two-Year Old Divisions of this Futurity and all conditions and requirements of those Divisions must have been fulfilled. (2) \$25.00 must be paid to the Futurity on or before June 15th of the year the entry becomes a Three-Year-Old. <b>HOW SHOWN.</b> The entries in this division shall be shown as (1) Three Gaited (2) Five Gaited (3) Fine Harness (4) Three Gaited Pleasure (May be ridden by a professional)

<b>HOW THE PRIZES ARE DIVIDED</b>	<b>PRIZES</b> The value of the prize fund of the Futurity each year shall be the total amount of money paid in fees less administrative expenses. Miscellaneous funds and allocated added donations shall be distributed to the Prize Fund at the discretion of the Futurity Board. Each year the specific awards to the nominators of sires and dam will be deducted before the division of the prize fund among the four regular divisions of the Futurity. The administrative cost will be deducted from general receipts. The nominator of the sire of the Champion foal in the Weanling Division will receive \$50.00. The nominator of the sire of the Reserve Champion foal in the Weanling Division will receive \$25.00. The nominator or the Dam of the Champion Foal of the Weanling Division will receive \$50.00. The dam of the Reserve Champion foal of the Weanling Division will receive \$25.00. In the Weanling and Yearling Divisions, the winner will receive 35% of the Prize Fund of the Division; second 25%; third 15%; fourth 12 1/2%; fifth 7 1/2%; sixth 5%. <b>In the Two-Year-Old and Three-Year-Old Divisions, prize money will be awarded to first through fourth places.</b> In the Two-Year-Old and Three-Year-Old Divisions, the winner will receive 40% of the prize fund of that division; second 30%; third 20%; fourth 10%; fifth, ribbon; sixth, ribbon. The prize fund shall be divided equally among the Weanling, Yearling, Two-Year-Old, and Three-Year-Olds. All money in the Prize Fund shall be paid to the winners.								
<b>HOW PAID</b>	<b>FEES</b> All payments must be made to the NWSA Open Futurity and mailed on or before the dates herein specified or bear postmark before midnight of such dates. In the event a closing date falls on a Sunday or legal holiday, postmark may bear the following business date. The US Postal Service may re-cancel mail that has been back-dated by a meter. <b>GRACE PERIOD:</b> five calendar days after payment due date. This rule is strictly enforced.  <b>LIABILITY</b> No entry is liable for more than the amount paid in. There will be no return of payment. The right is reserved to reject any entry and to debar any entry from competition for failure to comply with the conditions of this Futurity.
