U.S. Equestrian Entry Agreement

I have read the U.S. Equestrian (the Federation) entry agreement (Article 906.4) as printed in the prize list for this competition and agree to all of its provisions. I understand and agree that by entering this competition, I am subject to Federation rules, the prize list, and local rules of the competition. I agree to waive the right to the use of my photos at the competition, and agree that any actions against the Federation must be brought in New York State.

U.S. Equestrian Release, Assumption of Risk, Waiver and Indemnification

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this competition — NWSA Fall Classic & Futurity Horse Show — to the following:

I AGREE that I choose to participate voluntarily in the competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("harm").

I AGREE to release the Federation and the competition from all claims for money damages or otherwise for any Harm to me or my horse and for any harm caused by me or my horse to others, even if the harm resulted, directly or indirectly, from the negligence of the Federation or the competition.

I AGREE to expressly assume all risks of harm to me or my horse, including harm resulting from the negligence of the Federation or the competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the competition and to hold them harmless with respect to claims for harm to me or my horse, and for claims made by others for any harm caused by me or my horse at the competition.

I have read the Federation rules about protective equipment, including GR801 and EV113, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this release on the child's behalf.

I AGREE that "the Federation" and "competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form.

SUMMARY OF 2008 QUALIFICATION GUIDELINES

(Go To www.saddlebred.com/files/regchguidelinespdf31julv07.pdf for a complete set of guidelines)

1. To compete in the regional championships, a horse must compete and receive a ribbon in a class in three separate competitions in the same section within the Saddlebred Division during the qualifying period.
2. The qualifying period for 2008 is between the close of entries for NWSA Fall Classic and Futurity Horse Show 2007 (September 8, 2007) and the close of entries for the same show in 2008.
3. If a horse has been sold during this period, the qualifying records go with the horse. (Equitation not included)
4. If a horse has qualified in more than one region, only one region can be declared by the owner for this horse. Declaration needs to be submitted to ASHA by August 15, and may be emailed to b.newell@asha.net, or faxed to (859) 259-1628 attn: Brenda.
5. Qualifying shows need not be USEF rated, but they must be listed/recorded in the ASHA database of competitions
6. Previous residency requirements for horses stabling, or residence of owners are now replaced by the new qualifying requirements.
